VETERINARY SURGEONS ACT 1974

VETERINARY SURGEONS (AMENDMENT OF SECOND SCHEDULE) ORDER 2011

IN exercise of the powers conferred by subsection 12(3) of the Veterinary Surgeons Act 1974 [*Act 147*], the Minister, after consulting the Council, makes the following order:

Citation

1. This order may be cited as the **Veterinary Surgeons (Amendment of Second Schedule) Order 2011**.

Amendment of Second Schedule

2. The Second Schedule to the Veterinary Surgeons Act 1974 is amended—

(a) in Part I—

- (i) in relation to the country “Indonesia”, by inserting after the particulars relating to it the following particulars:

“Universitas Airlangga	Doctor of Veterinary Medicine”; and

- (ii) in relation to the country “Malaysia”, by substituting for the words “Universiti Putra Malaysia” the words “Universiti Pertanian Malaysia/Universiti Putra Malaysia”; and

(b) in Part II, by inserting after the country "Pakistan" and the particulars relating to it the following particulars:

"Taiwan	National Taiwan University	Bachelor of Veterinary Medicine
